I, the undersigned Ernst von Raussendorff, residing at Essen-Bredeney, having been instructed about the significance of an oath and warned that the making of a false affidavit is punishable, make the following deposition under oath for submission and in evidence before the Military Tribunal in Nuremberg:

From 1934 until 26 March 1945 I worked as head of the agents' office of the firm of Krupp in Essen. I recollect and having had recourse to the files I have also satisfied myself that my recollection is correct - that in connection with efforts made by Herr Krupp von Bohlen to obtain the release of our agent in Norway, Herr Hj. Krag, Oslo, the following communications came through my office:

- 1.) Telegram of Herr Krupp von Bohlen to Terboven, dated 29 January 1942
- 2.) Teletype message of Terboven to Herr Krupp von Bohlen, of 31 January 1942.
- 3.) Letter of Herr von Bulow to Herr von Bohlen, dated 7 February 1942.
- 4.) Communication without date of a man called Plotzki, to our Main Administration for Ore Mining in Essen, regarding the impending release of Herr Krag.
- 5.) Letter of Herr Krupp von Bohlen to Terboven, dated 21 February 1942.

These papers were kept in the files of the agents' office as carbon copies or as copies.

Expressing my regret to have missed you this morning and referring to telephone conversation of Herr von Buelow with deputy Gauleiter (Gau leader) Schlessmann, I present our urgent request for the release of our agent, Major Krag, who is being held under arrest as a hostage. Having worked together with him for almost 40 years we have come to know Major Krag as an honorable man with ethical standards who at all times has shown greatest understanding for the German standpoint. At present Major Krag, together with Dr. Plotzki, is looking after our Molybdenum interests in Norway which are of strategic importance and which would most seriously suffer were he to be eliminated. Considering, furthermore, his age of 75 years detention appears to be a great hardship. Hoping you will find it possible to comply with my request and conveying my best wishes to you for your extremely difficult and responsible activity,

S E C R E T !

Dear Herr Krupp von Bohlen :

I very much regret that for important and basic political considerations I am unable to comply with your request for the release of Major Krag. It has been conclusively established during the last raid which the British made on the Lofoten - when another 9 civilian Norwegians who were unarmed were carried away merely because of their being NS (National Socialists) - that upon the express request of the Norwegian Government for which the ex-king is responsible - the British Navy was given orders to capture each NS member on which it can lay hands and to take them to England. In view of this measure which makes a mockery of International Law I have arrested 20 personalities who are close to the King. Krag also is one of them, and is known as being on most intimate terms with the ex-King and as long as I am in Norway, he has certainly not shown his special understanding of German interests.

In view of the attitude taken by the ex-King, I am not in a position to take into account

for my measures of reprisal the age of the person in question. To me the life and liberty of one SS member is more important than the life and the liberty of the 75 years old friends of the ex-King. If the latter retracts his measures there will then be no need for me to take counter-measures.

As regards operations of the Molybdenum mines which - because of their strategic importance for the war - are being looked after by Dr. Plotzki and directly through the Reich Commissioner's office, Krag so far did not pay any attention to them whatsoever. One merely needs to give somebody else authority to sign responsibly.

I am convinced that you will appreciate these arguments.

Subject: Major Krag

Herr Alfried has asked me to inform you that he was able to see Herr Schlesmann who returned yesterday from Oslo. Herr Schlesmann had said that Gauleiter Terboven will not permit himself to be dissuaded from his decision; that he will carry through this measure of reprisal and that Major Krag will have to pay for it. That, furthermore, Gauleiter Terboven is convinced that Major Krag has not devoted himself to protect German interests in the way it was expected, quite particularly not as regards the ore mines in our care.

As there can be no question of making an appeal to the Fuehrer it will not be possible to do anything more under the circumstances. Herr Alfried shares our opinion that it also would not be advisable that you now send a reply to Gauleiter Terboven's teletype. We believe that the question as to whether and in which manner you may express your comments to Herr Terboven as regards the teletype message can wait until you have returned to Essen.

Dear Reich Commissioner Terboven !

I should like to come back to the matter of our representative, Major Krag. It grieved me deeply, that at the time you could not comply with my request to release him, all the more so as our officials because of closest cooperation are convinced that not only has Herr Krag at all times shown an understanding for the German point of view but that he also - to the extent that this was in his power - has given his support to German interests. I now hear that notwithstanding the arguments which you expressed in your teletype message of 31 January - Herr Krag has been released and I am anxious not to lose time in expressing my joy to you and to assure/or my gratitude. I am sure that Herr Krag will never be disloyal towards us and it is my hope that he still will be able to render many a service to Krupps interests and with it to the interests of Germany.
